HIGHLIGHTS

Balance Sheet

- Cash is \$342,241
- Unrestricted Fund Balance is now at \$127,127. \$84,380 is available for Foundation use.
- Restricted Funds is \$205,227. Individual fund balances reflect funds still available for their stated purpose.

Fund Activity Report

- Note a number of funds reflect a zero balance. That is because these fund activities have been completed and funds transferred as appropriate. As these funds have a zero balance, they will not appear on the Balance Sheet under Restricted Net Assets.

Income Statement

- Interest income for the current month is \$547 and \$10,381 year-to-date.
- Car Show income was accrued at \$2,000 for the prior fiscal year end. These proceeds were not achieved so the accrual was reversed and therefore showing a \$2,000 credit in Other Program Revenue
- Total Awards and Grants issued for the year-to-date is \$72,270
- The \$2,881 Released from Restriction is the proceeds of \$850 from the Great FV Campout and \$2,031 from Hall of Fame which represent closed events whose net proceeds have been transferred from its restricted purpose to the unrestricted fund.

Net Increase/(Decrease) Year-to-Date

- The Foundation Unrestricted Fund decreased by \$704.
- Restricted Funds decreased by \$59,350.
- These balances should increase in the remaining months of the year with Summerfest, Spring Poker and continued interest income to provide additional funds.

The team is in desperate need of new pole vault standards (full pole vault apparatus). Our current pole vault equipment is outdated and is in a state of decline due to aging and weathering. New equipment is vital for the safety of our FVHS student athletes as well as those from visting high schools during meets.

WHAT IS EXPECTED TO BE ACHIEVED?

The purchase of new Pole Vault Standards which will provide our athletes (and those from visting schools) updated equipment, and a greater level of safety every day in practice and during track and field meets. Acquiring grant money to assist with this cost will allow the boosters to utilize more money to assist student athletes in need with personal equipment costs such as uniforms, spikes, and travel meet costs. The "pit" (mats) was recently purchased (\$30,000) after mulitple years of saving.

LIST OTHER POTENTIAL FUNDING SOURCES FOR THIS PROJECT WHOM YOU HAVE

CONTACTED (e.g. corporations, foundations, individuals - indicate amount sought from each)
The program is entirely supported by voluntary donations by the athletes and the entry fees from the Central Park Invitational (XC meet organized and run by this organization every October - usually attracting 200+ teams from several states). Recently, possibly due to economic hardship, fewer and fewer families are contributing their voluntary donation. This lack of funding makes it difficult to replace aging equipment regularly.



Mothers Against Drunk Driving (MADD) has been a trailblazer in the fight against drunk driving since its inception in 1980.

As one of the US's most successful public health and safety organizations, MADD's advocacy and grassroots efforts have played a pivotal role in transforming public perceptions and enacting life-saving legislation.


