**Requests to Speak.** To provide comments during the meeting, in-person attendees, please fill out the public speaker slip and provide it to the clerk at the beginning of the meeting. Speakers via Zoom meeting by computer, mobile phone, or dial-in number use the “Raise Hand” feature. Members of the public who have requested to speak will be recognized at the appropriate time. This will notify the Clerk that you wish to speak during Public Comment. If joining the meeting using the Zoom dial-in number, you can raise your hand by pressing \*9. Members of the public will not be shown on video but will be able to speak when called upon.

Comments shall be limited to three minutes when speaking.
